The Final Payment (balance) will be due on April 30, 2009. Invoices will be mailed out by March 31, 2009 as a reminder. If a registered participant's Final Payment is not received by the due date, it will immediately become subject to a \$100 late fee penalty. If the Final Payment and late fee are not received by May 15, 2009, the participants reserved place on the tour roster will be terminated and a person on the standby list will take your place on the roster. Said termination will also forfeit any return of your Tour Reservation Deposit . There will be no exceptions to these payment parameters.

*The Tour Reservation Deposit, hereinafter referred to as the Deposit, is used to plan the tour logistics and to pay for the expenses required and associated with taking the tour from a dream on the website to a functioning reality for each participant. Partial deposits, and sometimes full payments, for hotel / motel accommodations and for the necessary facilities and equipment must be purchased and / or paid for well in advance of the actual tour dates. If any participant is required for any reason to cancel their reserved place on the tour roster after paying their Deposit before the tour begins, the non-refundable Deposit will be used by ROADHOUSE 66 LLC to defray the costs of said cancellation or termination.
